NOTE OF GRATITUDE

I am really thankful for all the support and peace of mind that Komen Colorado provides to people in such a stressful time of their lives.

I was diagnosed with stage IIB breast cancer. I had a double mastectomy in December 2016, and I started chemotherapy January 26, 2017, and finished June, 9, 2017. I had 16 rounds of chemotherapy and 33 radiation treatments.

The treatment grant saved me from possibly losing my house because I have been unable to work during treatment. Our financial situation was much worse than normal due to the aftermath of the flood we experienced in our area.

Komen Colorado couldn't have come at a more perfect time.

My insurance unfortunately does not cover office visits, and there are so many office visits involved with my treatment. That's easily \$300 per visit which I cannot afford. I also received gas cards from Komen which was very helpful because my home is 140 miles round trip from the cancer center.

Having the Komen Colorado grant gives me peace of mind and lowers my stress level during a really trying time knowing that my bills are going to be covered.

I am really thankful for the research and support the Komen Colorado grant offers locally and nationally.

POUDRE VALLEY HEALTH

The University of Colorado Health Cancer Center provides vital cancer treatments to patients living in northern Colorado. The UHealth Cancer Center is part of Poudre Valley Hospital (PVH), which receives support from the PVH & MCR Foundation through grant funds to support the uninsured and underinsured patient population.

Through the PVH & MCR Foundation, the UHealth Cancer Center has received a grant from Komen Colorado for more than 10 years, totaling more than \$1,360,000. These funds have covered the cost for breast cancer screenings, diagnostic tests, treatments, transportation, and patient navigation for women and men who would otherwise forgo the care they needed due to cost or other barriers.

In 2016, the PVH & MCR Foundation held a grant for \$25,000. With those funds, the UHealth Cancer Center provided breast cancer treatments for 27 patients, including Paula.

Without community partners like the PVH & MCR Foundation, Komen Colorado would be unable to impact the lives of breast cancer patients throughout the state. The community partners speak directly to patients to determine their needs and concerns. Komen Colorado receives that information to ensure resources are put in place to help individuals like Paula get the care they need.

Thank you to the PVH & MCR Foundation and all our 2016 community partners for making life-saving differences in Colorado.

OUTREACH

EDUCATION & OUTREACH

In 2016, Komen Colorado was out in the community, empowering people to make healthy decisions about their breast health by providing public education about breast cancer risk **at 29 events**. Komen Colorado volunteers totaled 177.5 hours, **saving Komen Colorado over \$4,000 in expenses**.

AFRICAN AMERICAN OUTREACH

- 60 attended the Pink Sunday brunch on April 23, 2016
- 30 attended the “Staying Connected” event on September 10, 2016
- Seven churches/places of worship hosted Pink Sundays in September and October 2016
- Attended four community

events targeted to African American women: Five Points Jazz Fest, Juneteenth, Destination Health 5K, and Celebrating Women’s Health

HISPANIC/LATINA OUTREACH IN MOUNTAIN COMMUNITIES

- 139 Spanish-speaking women in Garfield, Eagle & Pitkin counties were educated about breast cancer risk & screening guidelines
- 110 women were connected to health care providers for breast cancer screenings & diagnostic tests
- Nine new Spanish-speaking volunteers trained as community advocates
- Attended Rally in the Valley, Ladies Night Out, 9HealthFair, Strawberry Days, and Feria de Salud events to provide breast health resources

VOLUNTEERS & COMMITTEES

In addition to a Board of Directors, Komen Colorado has 10 advisory committees, comprised of five to 15 volunteers each. Committee members volunteer their time to provide strategic direction and to organize our three signature events.

In total, advisory committee volunteers spend more than 1,600 hours a year to support Komen Colorado’s mission, **saving Komen Colorado more than \$39,000 in administrative costs**.

GRANTS PROGRAM

ABOUT

Komen Colorado's community grants program helps fulfill the mission by funding local non-profit organizations to provide education about breast cancer risk, breast cancer screening guidelines and how to access health care, and to connect people to breast cancer clinical services in Colorado.

ASSESSING RISK AND IDENTIFYING NEEDS

In 2016, Komen Colorado awarded nearly \$970,000 to 18 non-profit organizations, hospitals, and health clinics. The funds are used to address disparities in breast cancer outcomes among vulnerable communities as determined in the 2015 Community Profile. The Community Profile identified four populations at greater risk of experiencing adverse outcomes from breast cancer:

1. Medically underserved women in Front Range counties
2. Rural northeast Colorado
3. Mountain/resort communities
4. Hispanic/Latina women

By providing grants to community organizations that provide breast health services in these areas, Komen Colorado aims to:

- Improve screening frequency
- Increase the number of women who enter into or remain in breast cancer treatment
- Reduce last-stage diagnoses and deaths
- Reduce cost, transportation & other barriers to clinical breast cancer care
- Reduce confusion about breast cancer screening guidelines & risk factors

GRANTS PROGRAM PRIORITIES:

- Women who have never been screened for breast cancer or haven't had a mammogram in the past two years
- Women who are more at risk of being diagnosed at a late stage
- Women who are more at risk of dying from the disease

LOCAL GRANTS PROGRAM

REQUEST FOR APPLICATION (RFA)

Komen Colorado strives to create a competitive and geographically-relevant granting process. Komen Colorado distributes the RFA to solicit applications for grant funding to implement breast health programs in line with funding priorities for target communities. Komen Colorado offers applicants grant-writing trainings to help them respond successfully to the RFA.

LETTERS OF INTENT (LOI)

Komen Colorado accepts LOIs each fall. If the LOI is found to fall within the scope of Komen Colorado's funding priorities and organizations are eligible, applicants are invited to submit a full application.

SELECTION PROCESS

While Komen Colorado staff review initial applications to ensure general eligibility

criteria are met, Komen Colorado does not determine which programs receive grants. Grant applications are evaluated by an independent grant review panel.

Grant Review Panel (GRP)

The GRP is comprised of individuals with backgrounds in breast cancer, grant writing/reviewing, nonprofit management, medicine, and finance. The GRP reviews, ranks and recommends grant applications for funding.

Since 1991, Komen Colorado has invested more than \$42 million into the service area, helping thousands of women and men receive breast health care at more than 120 community organizations.

Board of Directors

The Komen Colorado board of directors receives the final ranked list of projects recommended for funding. The board must either accept or reject the full list of applicants. If the Board cannot agree to

approve the entire recommended grantee list, the GRP must address the board's concerns.

ALLOCATIONS & EVALUATIONS

Grants are awarded in the order in which they are ranked to fund as many applicants as financially possible. Grant funds are based on Komen Colorado's annual revenue generated through our signature events and other sources.

Grants are bestowed to evidence-based projects that:

- Contribute to overall goals to reduce breast cancer mortality rates
- Close breast cancer outcome gaps
- Increase the number of patients who remain in care
- Educate individuals about breast health care

Komen Colorado monitors grant-receiving organizations throughout the year to ensure funds are used as intended.



ENSURING EQUALITY OF CARE

With the money raised for the fiscal year April 1, 2015 - March 31, 2016, Komen Colorado awarded \$969,969.34 to 18 breast health community partners.



Komen Colorado's service area includes 22 counties, home to 3 million people, or 72% of Colorado's population.



ENERGIZING SCIENCE

PUBLIC POLICY

To achieve its vision, Komen Colorado advocates on Capitol Hill for quality care for all. We lobby state and federal elected officials to protect and expand access to life-saving breast cancer care and to protect federal funding for cancer research.

State Advocacy


In 2016, staff worked with state representatives to draft a bill that would require insurance plans sold in Colorado to cover 100% of the costs of diagnostic procedures after an abnormal mammogram. The bill passed the State House of Representatives, but failed in the State Senate.

Federal Advocacy

In 2016, Komen Colorado lobbied Congress to protect federal funding for the National Breast & Cervical Cancer Early Detection Program. Komen Colorado also lobbied for funding of the National Cancer Institute and the Department of Defense's Medical Research Program.

GLOBAL RESEARCH

\$450,000 invested in national breast cancer research programs



RESEARCH SAVES LIVES

With the support of medical research, the death rate from breast cancer in the U.S. is 39 percent lower than it was 25 years ago. Susan G. Komen is the second largest funder of breast cancer research, after the U.S. government, investing more than \$920 million since 1982.


